## IN MEMORIAM: JUDITH B. PIERCE & SUE O. MOORE

In 2014, the Licking County community and the Licking County Foundation lost two, very compassionate leaders and dedicated friends. Judy Pierce was the secretary and treasurer of the Licking County Foundation's Governing Committee. She also co-chaired the Finance and Investment Committee. She joined the board in 2008 and guided many Foundation committees through the years, including Executive, Grant Review, Human Resources, Nominating and Scholarship Review. In addition to her service to the Licking County Foundation, Judy was an engaged and respected community volunteer, giving generously of her time and expertise to many organizations, including Licking Memorial Health Systems, The Midland Theatre, and Newark Rotary Club. During her career, Judy was a Business Manager and General Manager of Times Mirror Cable Television, Cox Communications and Frontier CableVision.

Sue Moore joined the Foundation's Governing Committee in 2014, and served on four committees: Education Grant Review, Nominating, Scholarship, and Scholarship Review. As a member of the Scholarship Review Committee since 2009, she evaluated hundreds of scholarship applications. Sue and her late husband, Bill Moore, were long-time supporters of the Licking County Foundation. They established the William S. and Sue O. Moore Fund in 1995 to benefit the parks and public land within the City of Newark. In 2006, the Moores and three other donors provided the funds needed to build a new home for the Licking County Foundation. Sue also devoted her energy to Newark and its citizens serving as the First Lady of the City of Newark from 1983 to 1991 when Bill was Mayor. Judy Pierce and Sue Moore will both be long remembered for their legacy of kindness, care for others and giving spirits.

# New FUNDS

Year after year, the Foundation's family of funds strengthen almost every aspect of life in our community. Each of our charitable funds is an inspiring reminder that our capacity to give is limited only by our imagination.



## CONSTANCE C. BALDWIN FUND

A field of interest fund established through a bequest from the estate of Constance C. Baldwin to provide opportunities and assistance to benefit and support children physically, educationally and culturally and to provide them with the means for recreation. Mrs. Baldwin, who died in 2014, was inspired by her father, Dr. F. E.

Corkwell, to give back: When she asked him, "How can I thank you for all the things you've done for me?" He replied, "You can't, you can only do for others." A graduate of The Ohio State University, Connie Baldwin received a Bachelor of Arts degree in Education and was employed as a teacher with Newark City Schools for 21 years. She taught 3rd and 5th grade at Cherry Valley Elementary School, and later taught junior high school special education. A 2010 Everett D. Reese Award honoree, Mrs. Baldwin's philanthropic focus was always on youth and education. She supported many local organizations and causes and enjoyed playing bridge and gardening.

## CANAL MARKET DISTRICT FUND

A project fund established by the Thomas J. Evans Foundation for the purpose of constructing the Canal Market District in downtown Newark's south side. The centerpiece of the district will be the Canal Market Plaza, three separate structures forming an open-air market on what is now a gravel parking lot bordered by Canal, Market, Second and Third Streets. The project includes improvements to the adjacent Second Street Parking Garage, burial of overhead power lines, and a brick walkway from the Licking County Courthouse through the market to the Pennsylvania Railroad Station on Walnut Street—plus new gazebos, a public restroom and a green space.



## DR. HENRY LYNN HOOK FUND

A designated agency fund established through a bequest from the estate of Dr. Henry Lynn Hook to provide ongoing support for the organizations and causes he cared about most: the Respiratory Therapy Department of Licking Memorial Hospital, the Herman S. Bauman Scouting Achievement Award, the Central Christian Church in Newark, the Licking County Humane Society, Licking County Foundation Unrestricted Fund, the United Way of Licking County, the Dr. Henry Lynn Hook Medical Scholarship Award, the National Tuberous Sclerosis Society, The Salvation Army, the Licking County Historical Society, the Navy-Marine Corps Relief Society, The Works, and Hospice of Central Ohio. Dr. Hook, who died in 2014, was born in Beaumont, Texas to Harry and Mabel Hook. The family moved to Newark in 1931. He graduated from Newark High School in 1942 and from the College of Medicine at The Ohio State University in 1948. In 1963, he returned to Newark to help in the development of the new Licking Memorial Hospital, and was the director of the pulmonary and respiratory department from 1966 until his retirement in 1989.



## LICKING COUNTY COURTHOUSE LIGHTING FUND

An agency fund established by the Licking County Courthouse Lighting Committee to provide an ongoing source of income to support the annual holiday lighting of the Licking County Courthouse and surrounding Courthouse Square, which may include design, purchase, installation, removal and

seasonal storage of holiday decorations and materials; and community and media communications, fundraising and lighting ceremony production. Since 1949, the annual lighting of the Licking County Courthouse has officially kicked off the holiday season, and this fund will ensure this treasured tradition will carry on for many generations to come.





## LICKING COUNTY VETERANS MEMORIAL AND EDUCATION CENTER FUND

An agency fund established

by the Board of Directors of the Licking County Veterans Memorial and Education Center for general support of the organization's mission which is to acknowledge, commemorate, and affirm the role played by Licking County, Ohio veterans in America's military past by means of developing instructive exhibits and other educational programs, constructing and maintaining a memorial wall, and insuring that no veteran who gave their life will ever be forgotten.



## TITTICA ROBERTS MITCHELL FUND

An unrestricted fund established through a bequest from the estate of Tittica "Tica" Roberts Mitchell to address the community's most urgent needs and emerging opportunities. Mrs. Mitchell, who died in 2014, loved the arts all of her life, both visual and performing. Her career was devoted to managing artists in the music

and fine arts industry. She worked closely with many of the leading classical musicians of the time, represented one of the most important touring vocal ensembles, and many symphony conductors were in her orbit. She was born in Newark to the late Joyce K. and Al V. Roberts, graduated from Newark High School, and earned a Bachelors Degree from The Ohio State University. She was married to William A. Mitchell who died in 2009. She resided in New York City for two decades; and then returned to Central Ohio, settled in German Village, and became active in Columbus life.

## SUSAN AND JERRY REID FUND

A donor advised fund established by Susan Reid, in memory of her husband, Jerry Reid, to support the charitable organizations and causes most important to the Reid family. Susan and Jerry were married for 38 years until his death on October 3, 2013. Jerry was a graduate of New Lexington High School and The Ohio State University; and Susan is a graduate of Newark High School, Ohio University, and Kent State University. Jerry retired from Rockwell International as the Supervisor of Traffic. Susan began her career as a teacher; and retired from Heath City Schools as a librarian where she was responsible for opening three school libraries. The couple shared a love of golf, traveling, their cat, Toby; and they cared deeply about supporting the community's nonprofit organizations.



## ROSS MORAN FAMILY NURSING SCHOLARSHIP FUND

A scholarship fund established through a bequest from the estate of Vinetta "Vi" A. Moran Battat to assist Licking County residents who are pursuing a degree in nursing at an accredited college, university, vocational/technical school or other post-secondary institution. Mrs. Battat, who died in 2014, was employed as a registered nurse for over 28 years in Dr. Mannino's office. She also worked at the Newark Healthcare Center and in private duty care. She was a member of the Perryton Historical Society, the Licking County Historical Society, and the Licking County Genealogy Society where she served as its first president in 1972. She was an avid cat lover and enjoyed bird watching. She was very talented in needle crafts. Mrs. Battat was preceded in death by her husband, Robert Battat, who owned the Walker & Battat Ford dealership in Newark. As a high school senior, Mrs. Battat decided to become a nurse when the head nurse from Newark Hospital came to her school to recruit students.

## LOIS FERNE TUCKER FUND

A designated agency fund established through the estate of Lois Ferne Sutton Tucker to provide ongoing support to Newark City School District for the purpose of scholarships for any type of advanced education beyond high school for any graduates of the Newark, Ohio public school system. Scholarship recipient selection shall be made by the Newark School District Scholarship Committee. The scholarship awards shall be made in the name of the Lois Ferne Tucker Memorial Scholarship. Ms. Tucker, who died in 1994 in North Plainfield, New Jersey, was a teacher in Newark City Schools.



## WELSH HILLS SCHOOL FUND

An agency fund established by the Board of Trustees of the Welsh Hills School for general support, including scholarships, programs and operating expenses. The organization strives to provide a dynamic educational program that combines the best of a challenging curriculum and a nurturing environment. In partnering with families and focusing on the whole person, their program creates respectful global citizens and confident, life-long learners. Above all else, Welsh Hills School embraces the idea that children should be encouraged to explore many different educational paths and embrace many different educational experiences, all with the goal of helping them to unlock and fulfill their human potential.

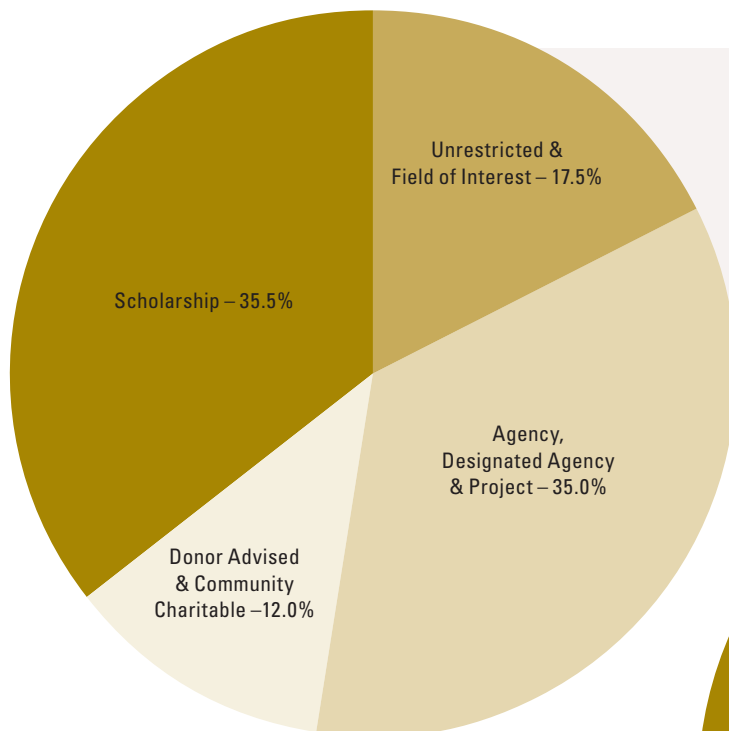

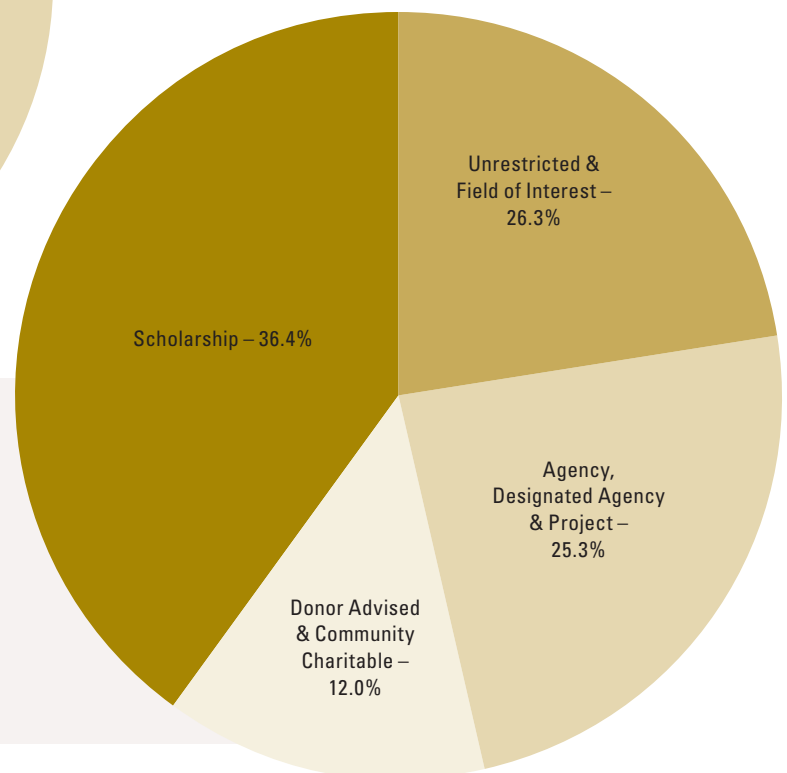

### BUILDING BETTER FUTURES

In July 2014, the Foundation's staff were joined by board members Eschol Curl and Cynthia Menzer to participate in a day of on-site construction at a Habitat home being built in east Newark. The Foundation's team joined a handful of other volunteers and future Habitat homeowners (see the family referenced in the previous story) to work on painting, flooring and the construction of a storage shed. Habitat partners with low-income families to build them simple, decent, affordable homes in neighborhoods that are most in need of revitalization and redevelopment. For every home that is built, several hundred volunteers provide an average of 2,800 hours of construction labor. The house that the Foundation crew worked on was dedicated to the new homeowner in September 2014.

**LICKING COUNTY HEALTH DEPARTMENT**

\$24,369 to support the application of dental sealants for low income children in grades 2, 3, 6 and 7 in Lakewood, Newark City and North Fork school districts to prevent tooth decay and protect their permanent teeth. Granted from the William E. and Annie S. Miller Memorial Fund.



"We have been able to screen 1,017 children and place sealants for 754 children to date. The team encountered a very sweet second grader who when he smiled, showed nothing but black front teeth. He was hoping that for Christmas he would receive white teeth. Twelve out of twenty of his baby teeth had big cavities, with two teeth decayed all the way down to the gum line...The team explained that they could not save his black teeth, but that they would apply "a coat of armor to the back teeth to stop the cavity creep". The team then sealed his back molars and sent a letter home to his family telling them that he needed to see a dentist and to contact the team or school for help in paying for the dental visit. The team also contacted the school nurse to make sure that she would follow-up with the family. They then gave the child a new toothbrush and taught him how and when to use it. They explained that he would have a second chance to have white teeth in the front when his baby teeth fall out, but only if he takes care of the new permanent teeth. The team was grateful that they were given the chance to serve this little boy. ..Those few minutes spent with him

will make a big difference in him keeping his permanent molars, hopefully for a lifetime."

**\$5,170 to support Pawsitive Influence, a program that subsidizes the adoption fees for at-risk populations such as the elderly, those with disabilities and special needs children. Granted from the Thomas M. Kier Memorial Fund and the Edgar W. and Phyllis L. McCauley Fund.**

**LICKING/KNOX GOODWILL  
INDUSTRIES, INC.**

**\$10,000 to support the GoodGuides youth mentoring program, which provides mentoring, career exploration and skill development to offer youth (ages 12 to 18) a pathway out of poverty and crime via family strengthening and positive development approaches. Granted from the William E. and Annie S. Miller Memorial Fund.**

"Grant funding was used for hosting out-of-school activities for students and their families—including an end-of-the-school-year/graduation party, bowling, a movie night, a holiday cookie baking/craft night, a Newark High School football tailgate party, and much more. Meals were provided for all of these activities to encourage families to sit, talk and eat together; and there was a dramatic increase in participation. The program's goals of having 70% of participating youth not offend or reduce delinquent behavior, decrease the number of behavior/discipline incidents in school, and show academic improvement were exceeded. A 14 year-old who is in 8th grade has been in GoodGuides for two years. She was soft-spoken and would not raise her hand or volunteer at school. Last year, she was failing most of her classes. She only participated in about half of the GoodGuides events and would stay in the background. She is now participating in the mentoring sessions and has greatly improved her grades. She and her family have attended the majority of the out-of-school activities during the school year."

\$36,000 to support the Licking Memorial Dental Clinic for Children, which provides access to preventative dental care to the uninsured children of Licking County's low-income parents. Granted from the William E. and Annie S. Miller Memorial Fund.



### MENTAL HEALTH AMERICA OF LICKING COUNTY / YES CLUB PROGRAM

\$50,000 to support an afterschool and summer haven, which increases student achievement by providing a positive, holistic climate that values and respects the individual needs of the high-risk, low-income 11-to-18-year-old participants and their families. Granted from the William E. and Annie S. Miller Memorial Fund and the Ernestine and John David Spencer Memorial Fund.

"I had no idea what I was in for the first time I came to YES, but before I had moved here I was lonely, secluded and looking for a way out. Then I came to YES and you guys make me feel so welcome, and suddenly the boy I was and thought I lost came back. So, in a way, YES Club saved me. All of you showed me I had something to live for—a family, friends and a place I can be myself. I had to grow up quick, I had my sister to look out for. You guys gave me a place to be a kid again. I'm so grateful for you guys. You do so much and ask so little."

### MIDLAND THEATRE

\$15,000 to support cultural and artistic programs for young people and families to be inspired and entertained together, including opportunities for those who could not afford this experience otherwise. Granted from the J.P. Shai, II Fund and the Unrestricted Fund.

"Staff from the Licking County Department of Job and Family Services wrote about the impact that the Midland's programs had on families referred to the Licking County Children's Services who are typically living at or below the poverty level: "Although they may be connected to social services to meet basic needs, they are usually isolated from the enrichment opportunities available in our community. When our families walk through the door of the Midland Theatre, it gives them an opportunity to experience a piece of history and culture that they might never experience otherwise. We know that this may be the first such experience in at least two generations because our parents tell us it is the first time they themselves have ever been inside the Midland, and they tell us how amazed they are by its beauty".

### MID-OHIO FOODBANK

\$25,000 to help purchase 125,000 pounds of fresh, nutritious produce that will be provided to the Food Pantry Network of Licking County for distribution through the new Produce Market program that serves low-income, food-insecure residents of Licking County. Granted from the Unrestricted Fund.

"At one of the Johnstown Markets we met a client who was helping to support 16 people all under one roof. She explained that at the end of the month, the extra food from the Market "really helps out." She and her children were excited to receive bananas and oranges. The fruit is this client's favorite because she likes to have an afterschool snack for her children. Additionally, the most surprising part of this year's Produce Market program was a single moment in which a five-year-old child visited a Market to pick out fresh produce and had never seen a banana before. The child was so excited to try something new."

\$10,000 to support the demolition of 20/22 N. Fourth Street for the creation of a public parking lot in downtown Newark. Granted from the Unrestricted Fund.

### NEWBORNS IN NEED (GREATER NEWARK OH CHAPTER)

\$5,000 to buy fabric, yarn, and other materials in bulk to have an adequate supply for sewing projects to serve premature and newborn babies who are ill or in crisis with complete layettes, including handmade clothing, quilts, blankets, sweater sets and other infant necessities. Granted from the William E. and Annie S. Miller Memorial Fund.

### THE SALVATION ARMY

\$10,000 to support the Power for Life afterschool program, designed to mentor at-risk teenage girls between the ages of 12 to 16 with afterschool tutoring and programming that builds self-esteem, supports abstinence, and teaches basic budgeting, good nutrition, fitness, life skills and conflict resolution. Granted from the William E. and Annie S. Miller Memorial Fund.



### THE SALVATION ARMY

\$10,000 to support the Summer Food Service Program to provide meals for children who receive free or reduced food at school during the school year. Granted from the William E. and Annie S. Miller Memorial Fund.

"The program served a total of 40,648 free, balanced and nutritional meals at six mobile meal sites throughout Licking County from June 9 to August 19, 2014, Monday to Friday. They found that planning activities helped draw children to the sites—like a new partnership with The Children's Reading Foundation to furnish books. One mother brought her six children to The Salvation Army during the summer so that they could eat lunch. She said, "I want to say thank you to The Salvation Army. Your feeding program enabled me to know that my children had at least one nutritional meal daily. Because of your program, I was able to pay my rent and other bills. Without this program, my family and I might have lost our home, because I would choose to feed my children instead of paying all of my rent. The food was delicious and my children really enjoyed the food. They also enjoyed being able to take books home to read. Thank you again for all you do for the community and especially for helping my family."

"During the inaugural year of Kids' Tech University™, we met our goal of enrolling 100 students, including scholarships for 25 students from Newark City Schools who otherwise would not have been able to participate. We heard many positive comments from parents and students about the value of the program, and here is an excerpt from one student's parents: "Kids' Tech has been a great experience for our son, who is in third grade at Licking Valley Elementary School...Our son got to participate in different groups of kids within and outside his age group, work on a college campus, put together research material, and present material to the judges—all experiences that improve confidence, independent thinking, and value of teamwork and processes."

# Scholarship PROGRAM

Our donors believe in the power of higher education and that the future of our area depends upon a well-educated and experienced workforce—almost 40% of the Foundation’s assets support scholarships. LCF awarded 367 scholarships totaling \$818,264 to area high school seniors, college students and adult re-entry students who attended 74 different colleges, universities or trade schools across the country. The scholarship awards ranged from \$1,000 to \$8,000, and many of this year’s awardees received LCF scholarships in previous years—some multiple times. Scholarship recipients were selected from a pool of 727 applicants by the Foundation’s volunteer Scholarship Review Committee.
