PLEDGE TO THE LICKING COUNTY FOUNDATION

I. I/we wish to give evidence of my/our interest in and support of the capital campaign to restore the Louis Sullivan Building of Newark.

II. I/we do so in consideration of the ongoing efforts of the Licking County Foundation to solicit funds for the restoration of the Louis Sullivan Building of Newark. I/we recognize that the Licking County Foundation will incur expenses in anticipation of payment of my/our pledge and will rely on my/our pledge in seeking commitments and pledges from others.

III. Based upon these considerations and in consideration of the commitments of others, I/we pledge and agree to pay to the Licking County Foundation, the total sum of \$ _____ payable in cash or investment securities (traded on a national stock exchange) of equal value. The value of the investment securities transferred in fulfillment of this pledge shall be the amount of the net proceeds realized by the Licking County Foundation upon its sale, which sale shall be made within a reasonable period of time following the Licking County Foundation's receipt of the property. The overall goal for the use of this pledge or gift is to fund the restoration of the Louis Sullivan Building of Newark. However, the funds also may be used, at the discretion of the Licking County Foundation, to pay for the expenses incurred by the Licking County Foundation during the campaign to include the repayment of indebtedness.

IV. I/we intend this pledge to be irrevocable, unconditional, and legally binding against me, my heirs and assigns.
